Sales Tax Holiday/Tax-Free Weekend

Texas shoppers get a break from state and local sales taxes on August 17, 18, and 19. Layaway plans can be used again this year to take advantage of the sales tax holiday. As in previous years, the law exempts sales and use taxes on most clothing, footwear, school supplies and backpacks priced under \$100, which saves shoppers over \$8 on every \$100 they spend.

Taxed items are defined as luggage, briefcases, athletic/duffle/gym bags, computer bags, or framed backpacks. Ten or less backpacks purchased at one time can be tax free without providing an exemption certificate to the seller. Tax exempt qualifying school supplies if priced less than \$100:

- Binders
- Book bags
- Calculators
- Cellophane tape
- Blackboard chalk
- Compasses
- Composition books
- Crayons
- Erasers
- Folders; expandable, pocket, plastic, and manila
- Glue, paste and paste sticks
- Highlighters / Markers (including dry erase markers)

- Index cards / Index card boxes
- Lunch boxes
- Legal Pads / Writing Tablets
- Notebooks and Paper, loose leaf ruled
notebook paper, copy paper, graph paper,
tracing paper, manila paper, colored
paper, poster board, construction paper
- Pencil boxes and school supply boxes
- Pencil sharpeners
- Pencils / Pens
- Protractors / Rulers
- Scissors

TAX-FREE CLOTHING ITEMS

- Baby Clothes
- Backpacks / Backpacks with wheels that can be worn on ones back
- Belts with attached buckles
- Boots—cowboy, hiking
- Caps/hat - baseball, fishing, golf, knitted
- Coats and wraps
- Diapers - adult and baby
- Dresses
- Gloves (generally)
- Gym suits and uniforms
- Hooded shirts and hooded sweatshirts
- Hosiery
- Jeans and Jackets
- Jerseys - baseball and football
- Jogging Apparel
- Neckwear and ties

TAXED ITEMS

- Accessories - barrettes, elastic ponytail
holders, wallets, watches and all jewelry
- Backpacks—unless for use by elementary and
secondary students
- Baseball cleats and pants / Football pants
- Belt buckles (without belt)
- Boots—climbing, fishing, rubber work
boots, ski, waders
- Buttons and zippers
- Cloth, lace, knitting yarns, and other fabrics
- Dry cleaning and Laundering services
- Golf gloves
- Handbags and purses
- Handkerchiefs
- Hard hats and helmets—bike, baseball, football,
hockey, motorcycle, sports
- Ice skates, roller blades and skates
- Leather goods—except belts with buckles
and wearing apparel
- Pads—football, hockey, soccer, elbow, knee,
shoulder
- Personal flotation devices
- Rented clothing—includes uniforms, formal wear,
and costumes
- Safety clothing and safety glasses
- Shoes—bicycle (cleated), bowling, golf
