

Annual Trash Clean-Up

The annual clean up event is back at City Hall! The event will be held in the Municipal Complex Parking Lots:

- **Saturday, June 5, 2021 - from 7:00 AM to 4:00 PM**
- **Remember to bring proof of residency (copy of water bill or drivers license).**

We cannot accept paints, tires, oil, insecticides, items that are harmful to the environment, refrigerators, air conditioners, any Freon bearing items, batteries, or other hazardous material.

If you need to dispose of hazardous waste at any time, please visit our Water Department to purchase a voucher to Fort Worth's Environmental Collection Center. Vouchers cost \$50 and you must bring your driver's license or current water bill with you for proof of residency.



Code Corner

We would like to remind citizens of some of our city codes:

Unightly Storage

Storage of items on front porches, carports, and side yards could become dangerous and unsightly. Storing items such as: indoor furniture, appliances, construction material, household items, toys, scrap metal, automotive parts, tires, clothes, etc. visible to the public is a Code Violation. The accumulation of these items on front porches and carports is an invitation to vandals looking for valuables, potentially endangering citizens, and is unsightly for the neighbors.

Covering outside storage piles or screening the front porches and carports with tarps and other material is not a remedy to this problem.

Alleyway Maintenance

Property owners or occupants are responsible for maintenance of trees and shrubs which overhang alleys or plantings, shrubs and trees planted by the adjacent property owner in the parkway. (Per City Ordinance 6.05.003)

As the city has been experiencing heavy rain and more greenery is beginning to appear, citizens that have property adjoining the alleys must keep their portion of the alleys clear and ensure there is not overhang impeding vehicular traffic.

Additionally, street numbers are required to be displayed in a manner that is visible from the alleys, be a minimum of 3.5 inches in height, and in a color contrasting with the background (Per Fire Code and City Ordinance Sec. 5.04.002 - Sub Section 505.1)

If found to be in violation of these ordinances, you are subject to receiving a citation to appear in Court.

Pet Information

As the weather warms and your furry friends begin spending more time outside, please be aware that it is against city ordinance (Sec. 2.01.005) for dogs to be off leash if they are not confined. Animal control is authorized to impound such animals running at-large.

Additionally, as required by city ordinances (Sec. 2.01.004), all cats and dogs **MUST** be registered with the city. In order to do so, come into the police dispatch lobby to complete the form, pay the registration fee, and receive a registration tag to be affixed the pet's collar. Anyone found to be in possession of an unregistered cat or dog is subject to receive a citation.

Lastly, as is required by city ordinance (Sec. 2.01.10), you must immediately and in a sanitary manner remove and dispose of all feces deposited on public or private property other than your own. Furthermore, Any person other than a disabled person who has a dog on a leash shall have on his or her person a plastic bag for the purpose of picking up such dog's feces. Such bag shall be presented upon request by any city officer or employee. Failure to do so can result in a citation.
