- City Administrator Roger Unger presented the preliminary budget, identifying changes from previous
 year, including new nursery green, the re-alignment of the course, new wetting agent process, remodel
 of bar, increased play rates, additional tournaments, and change to liquor license.
- MOTION by Nick Encke to accept the Proposed and Preliminary Fiscal Year 2012-2013 Hawks Creek Golf Club Budget and recommend approval to the Council. **SECOND** by Jill Patton. Motion passed unanimously by a vote of 7 Ayes and 0 Nays.

4. Discuss and take action to approve the Proposed Fiscal Year 2012-2013 WRA Budget and submit to the City Council.

- City Administrator Roger Unger presented the proposed budget, discussing attorney fees due to ongoing lawsuits, the possibility of the WRA contributing to the funding of street repairs, WRA debt service, and gas well revenue previously allocated to capital improvements.
- MOTION by Ed VonKohn to approve the Proposed Fiscal Year 2012-2013 WRA Budget and submit to the City Council. SECOND by Mike Coleman. Motion passed unanimously by a vote of 7 Ayes and 0 Nays.
