I. Appoint Chair of the Committee.

- II. Approval of Minutes from Finance Committee Meeting August 12, 2014.
 - MOTION to approve the minutes made by Jill Patton. SECOND by Nick Encke. Motion passed unanimously, by a vote of 4 Ayes and 0 Nays.

III. Review and discuss FY 2013-2014 YTD Disbursements.

• City Administrator Roger Unger stated the year-to-date disbursements are consistent and where they should be – nothing abnormal. As we are nearing the end of the fiscal year, we are seeing some improvement in overall revenue, specifically in last month's court budget.

- IV. Discuss and take action with respect to Proposed FY 2014-2015 Budget, including General Fund, Water Fund, CCPD Fund, Capital Improvements Fund, Debt Service Fund, WRA Fund, and Hawks Creek Golf Club Fund.
 - Roger reviewed the summary sheets and formal budget transmittal letter. There are some minor
 changes to projections as we've received final data on health insurance and workers' comp rates, as
 well as added part-time hours at the library. The sale of the WRA-owned property on Calera Place
 will not close this fiscal year as hoped; it has been moved to projected revenue in the Fiscal 14-15
 budget.
 - Roger discussed the need for Council to hold two public hearings one this evening and the second next week.
 - Chairman Beckman stated his appreciation to the Mayor and Roger for their work on the budget. The package is very efficient in its understandability and asset allocation.
 - MOTION to recommend Council approval of the FY 2014-2015 Budget as presented made by Mike Coleman. SECOND by Nick Encke. Motion passed unanimously, by a vote of 4 Ayes and 0 Nays.
