 - MOTION made by Jill Patton. SECOND by Mike Coleman. Motion passed unanimously by a vote of 5 Ayes and 0 Nays.
- II. Discuss and take action with respect to FY 2013-2014 Audit, including recommendation to Council.
 - Chairman Beckman stated he reviewed the audit with Mayor Yeager, City Administrator Roger Unger, and the senior auditor. End-of-year audit entries included reclassification of gas royalties. The Auditor Opinion was ranked "Unqualified", which is the highest opinion given. Chairman Beckman is very pleased with the City's management team and their handling of the budget. Mayor Yeager

- commended the City and HCGC staff for their stewardship of the citizens' money and in bringing the City's budget to "the black".
- Roger discussed a specific audit adjustment to amend a revenue error in the Hawks Creek Golf Club
 old sales software to correctly match the Incode accounting system. Roger recommended acceptance
 of the final audit.
- MOTION by Nick Encke to accept the FY 2013-2014 Audit as presented and recommend Council approval. SECOND by Mike Coleman. Motion passed unanimously by a vote of 5 Ayes and 0 Nays.

III. Review and discuss FY 2014-2015 YTD Disbursements & Variance Report.

 Roger stated there are no new variances (other than what had been presented over the past few months). No further discussion.

IV. Discuss FY 2015-2016 Budget process.
