PRE-COUNCIL SESSION CALLED TO ORDER at 6:45pm by Mayor Yeager.

Action items announced individually. Discussion of agenda items, as follows:

6A: Alex Garcia, Freese & Nichols Engineer, reported six bids were received for the Randolph Court, Watters Place, and Wells Circle infrastructure rehabilitation project. McClendon Construction was the lowest bidder at \$1,119,262. The highest bid was \$1,347,355.50. Freese & Nichols has vetted the bid documents and recommends McClendon for the project. Mayor Yeager stated the City has used McClendon in the past. Councilman Coleman asked Alex to review the storm water drainage at the end of Watters Place to protect the trail.

6B: City Administrator Roger Unger stated the rate adjustment is already written into the contract. The increase is less than 2%.

6C: Councilman Coleman stated the change is to clarify and clean-up language only.

6D: Roger Unger explained Nova presented the City with a substantial rate increase forcing us to investigate other options. Harris Occupational Health, located in the Fort Worth Hospital District, is less expensive and can handle more intense medical needs.

A. Interim Police Chief, Lieutenant Glenn Lipperdt

• Police Dept Report: Priority Calls for Service 312, YTD 3802; Self-Initiated Calls 1461, YTD 14,782; 911 Calls 161, YTD 2180; Citations 241, YTD 3456; Violations 365, YTD 3456; Jail 51, YTD 603; Westover Hills \$2350 YTD revenue; Lakeside \$47,624 YTD revenue.

B. Ryan Studdard, Code Enforcement

- Code Enforcement Report: 98 code violations, 356 YTD
- Inspection Report: 48 inspections performed (30 Ryan + 18 Jerome), 449 YTD.

C. David Curwen, Director of Golf of the Hawks Creek Golf Club

• Golf Club Report: 3536 rounds played; \$152,207 in revenue; closed 0 days; 66 Preferred Player Members. 3 tournaments: TX Wesleyan Collegiate Ladies Invitation, TCU Letterman, I-Tour. Holiday rates are the highest source of revenue at 30%, followed by senior rates at 15%. The course was closed for a total of 43 days in the fiscal year. October play is going well and is a good start for FY 14-15.

D. Rhonda Hines, Librarian

- Library Report: This year's summer program was a big success. The post-season party was held at Burton Hill Elementary for participating students. The Library received the FY 14-15 Accreditation letter. Rhonda attended three training seminars in September (a three-day seminar and two webinars). Rhonda continues to find excellent resources to improve service to the community. Consortium participation is rising.

E. Roger Unger, City Administrator

- Capital Projects/Infrastructure: Tracyne/Coleman project final walk-through went well with only two minor items on the punch list. Next year's project will be on the agenda before the end of the calendar year.
- **TAP Grant:** Grant has been awarded and initial funds should be disbursed in March/April 2015. Per Alex Garcia, F&N, from planning to completion, the project is expected to take 18-24 months.
- Public Works Service Order Report included in the packet. Old fire station has been converted to the Public Works Bldg to house PW equipment and allow space for hands-on training opportunities.

Discuss and take action with respect to the construction bids for Randolph Court, Watters Place, and Wells Circle infrastructure rehabilitation project. [Council is asked to award construction contract to specific company, for specific work, up to specific amount.]

- In agreement with Freese & Nichols, City Administrator Roger Unger recommends approval of the lowest bidder, McClendon Construction.
- MOTION made by Nick Encke to award the rehabilitation project of Randolph Court, Watters Place, and Wells Circle to McClendon Construction at \$1,119,262. SECOND by Steve Beckman. Motion passed unanimously by a vote of 4 Ayes and 0 Nays.

C. Councilman Mike Coleman

- Councilman Coleman stated this change will add clarification on the definition of rubbish and handling of trash in the streets.

• MOTION made by Steve Beckman to designate Harris Occupational Health physicians as the City's Health Officers. SECOND by Mike Coleman. Motion passed unanimously by a vote of 4 Ayes and 0 Nays.

E. Mayor Yeager

Discuss and take action to pass Resolution No. 2014-08, designating The River Oaks News, a publication of Suburban Newspapers, as the City's official newspaper, for Fiscal Year 2014-2015. [This is an annual designation, done at the beginning of each fiscal year.]

- MOTION made by Jill Patton to pass Resolution No. 2014-08, designating The River Oaks News, a publication of Suburban Newspapers, as the City's official newspaper, for Fiscal Year 2014-2015. SECOND by Mike Coleman. Motion passed unanimously by a vote of 4 Ayes and 0 Nays.
- Councilwoman Patton stated her belief that the newspaper doesn't print enough about Westworth Village because they are not aware of things going on in the City. City Secretary Carol Borges stated she can add the editor to the distribution list for events, etc. Councilman Encke stated that the Westworth Park HOA has declined paper delivery within their community.
- 7. Executive Session called at 7:24pm with Mayor Yeager, Council Members Patton, Encke, Beckman, and Coleman, as well as City Administrator Roger Unger, and City Attorney Ashley Dierker in attendance.

At 7:51pm, Interim Police Chief Glenn Lipperdt, Director of Golf David Curwen, and Golf Superintendent Sterling Naron was asked to join the Executive Session.
